

Glen Eira Leisure Swim School Animal Naming Competition

Terms and Conditions

This competition ('Competition') is run by Glen Eira City Council ('Council') to promote Glen Eira Leisure Swim School ('GELSS') by engaging with its members and patrons. Entrants are invited to suggest names for any of the 10 GELSS animals and to provide a backstory for their chosen animal in 25 words or less.

1. By entering the Competition, entrants accept these terms and conditions of entry ('Conditions').
2. Entry is open only to residents of Victoria. Councillors, Council employees, contractors, Councillors, and their immediate family members are not eligible to enter.
3. This is a competition of skill and chance plays no part in determining the winner.
4. The Competition commences at 4.00pm on 7 November 2024 and ends at 11.59 pm on 21 November 2024.
5. To enter the Competition:
 - (a) entrants must be aged 6 months or over. Entrants under 14 years of age must have their parent or legal guardian's consent to enter the competition;
 - (b) The entrant must complete all required fields on the entry form located at <https://www.geleisure.com.au/swim-school/name-our-gelss-animals-competition>, including providing a suggested name for the chosen animal and a backstory (in 25 words or less);
 - (c) The entry must be submitted online at www.geleisure.com.au/swim-school/name-our-gelss-animals-competition or (email address); and
 - (d) The entry must be submitted by 11:59 pm on 21 November 2024.
6. Multiple entries are permitted, provided that a different name and animal are suggested for each entry.
7. The suggested name:
 - (a) Must align with Council's values;
 - (b) Must not contain any offensive or inappropriate language; and
 - (c) Must be original and not infringe the intellectual property rights of any other person.
8. Entries will be judged by a panel of three GEL staff members on 22 November 2024. Winners will be chosen based on the originality and creativity of their entries at the judging panel's discretion. In the event of multiple entries suggesting the same winning name, the panel will select a winner based on the provided backstory for choosing the name. The panel's decision is final, and no further correspondence will be entered regarding the judging outcome.
9. The winning name suggestions will be used as the official names of the GELSS animals at GESAC, as indicated through permanent signage in the aquatic area, on the website, and in promotional materials. The winning entrants name will not be present on the signage,

10. Each winner will receive a prize pack consisting of

- (a) a swim school robe;
- (b) a water toy;
- (c) dive sticks; and
- (d) Stickers.

There are no runner-up prizes for this competition. There will be a total of 10 prize packs, one for each winning animal name.

- 11. If an entrant is under 14 years of age on the date a Prize is awarded, it will be awarded to their parent or legal guardian. By approving the entrant's participation or accepting any Prize on the entrant's behalf, the entrant's parent or legal guardian agrees to be bound by these terms and conditions.
- 12. Prizes are not transferable, exchangeable, or redeemable for cash. Council is not liable for any loss (including but not limited to any damage, claim, injury, cost, or expense) suffered or incurred by any person in connection with the redemption or use of any prizes.
- 13. Winners must be able to collect their prize in person from GESAC at 200 East Boundary Road, Bentleigh East, VIC, 3165, by 29 November 2024 or at a later date as agreed by Council at its sole discretion.
- 14. Winners will be notified via email within one week of the judging panel's decision. In the event the winner is unable to comply with these conditions or the prize is unclaimed within 14 days of the winner being announced, Council reserves the right to award the prize to the valid entry judged to be second best in the competition in accordance with clause 8. In such circumstances, the winner will be notified by email within one week of being selected.
- 15. The winning names and the first name of the winner will be announced via Glen Eira Leisure's Facebook page and Instagram following confirmation of prize acceptance.
- 16. Upon submission of an entry, the proposed names will become and remain the Property of Council. By entering the Competition, the entrant assigns all rights, including intellectual property rights in the proposed names, to the Council. Entrants consent to the Council (or any third party on behalf of the Council) dealing with the proposed names in any way that may infringe the moral rights of the entrant (including not attributing the entrant as the creator of the name and modifying or adapting the name).
- 17. This promotion is in no way affiliated with Facebook or Instagram.
- 18. The Council is not liable for late, lost, incomplete, invalid, or incorrectly submitted entries, or illegible, corrupted, or misdirected entries, claims, or correspondence due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption and communications failure, or otherwise.
- 19. If for any reason any aspect of the Competition is not capable of running as planned, including by reason of tampering, unauthorised intervention, fraud, technical failure, or any cause beyond the control of the Council, the Council may, at its absolute discretion, cancel, terminate, modify, or suspend the Competition or invalidate any affected entries.
- 20. Council reserves the right, at any time, to verify the validity of entries and the eligibility of entrants and to disqualify any entrant who does not meet the eligibility criteria set out in this paragraph 5 or who submits an entry that is not in accordance with these conditions.

21. Council reserves the right to alter or amend these terms and conditions at any time without further recourse to the entrants.

22. **Privacy Statement**

The personal information an entrant provides will be used to conduct the Competition and to communicate with entrants. If the requested information is not provided, the entrant may be ineligible to enter the competition.
